

COVID-19 ADVICE FOR FAMILIES

COVIDsafe Measures

COVIDsafe measures have changed but we continue to implement important practices to reduce the risk of COVID-19 transmission.

We will continue to ensure:

- air purifiers are in use
- external ventilation is maximised
- good personal hygiene is encouraged and
- face masks continue to be made available for staff, students and visitors who wish to wear them.

Vaccinations

Families are strongly recommended to ensure they keep up-to-date with all recommended and available COVID-19 vaccinations as vaccinations are the best way to protect individuals, families and school communities from the severe effects of COVID-19 and reduce the spread of the virus.

Vaccination is no longer mandatory for staff, senior students or visitors in any Victorian school.

Rapid Antigen Testing

It is recommended that rapid antigen tests (RATs) are used by students:

- If they have symptoms of COVID-19 infection, no matter how mild.
- If they are a household or close contact of someone who has COVID-19.
- If they are a social contact of someone who has COVID-19.

Reporting Results

The Department of Health no longer requires Victorians to report a positive RAT result.

As with any illness, parents are asked to notify VCC of a positive Covid result for their child by e-mailing attendance@vcc.vic.edu.au or adding an absence note to Xuno.

VCE students who are missing a SAC must provide a medical certificate when reporting to the College.

RAT kits

Rapid Antigen Tests are also available for all Victorians from Council sites. People can get 2 free packs (10 tests) for themselves and 2 free packs (10 tests) for each of their household members.

People with a disability and their carers can get up to 4 free packs (20 tests) in line with existing RAT distribution for people with a disability.

Face Masks

Current advice from the Victorian government is available on the 'face masks' page of the Coronavirus site.

Students who wish to wear a face mask will be supported to do so.

The Department of Health recommends that masks should be worn by a person who is a close contact of someone who has tested positive for COVID-19 when leaving home.



Additionally, the Department of Health recommends that masks should be worn by a person who has COVID-19 for at least 7 days after a positive test when they need to leave home.

Infection Prevention and Control

Students and visitors to schools should practise good hand hygiene, particularly on arrival to school, before and after eating, after blowing their nose, coughing, sneezing or using the toilet. Staff will direct or supervise young students where required.

Management of Suspected Cases of Covid-19

A 'suspected' case means a person who displays any <u>COVID-19 symptoms who has not yet tested positive for COVID-19</u>.

A student or visitor who is symptomatic is recommended to undergo testing for COVID-19. Parents of students who are symptomatic will be asked to collect their child from school and to keep them home until they are no longer symptomatic.

Management of Confirmed Cases at VCC

Students who report a positive result are recommended to isolate for a minimum of 5 days and not attend school until their symptoms have resolved.

Students who isolate as a result of a positive COVID-19 test will be supported in the same way as students with an extended absence due to illness or injury, with accessible learning materials provided to support their continued learning.

Please note, in line with the DET Guidelines, the College will no longer deliver a full Remote Learning program.
